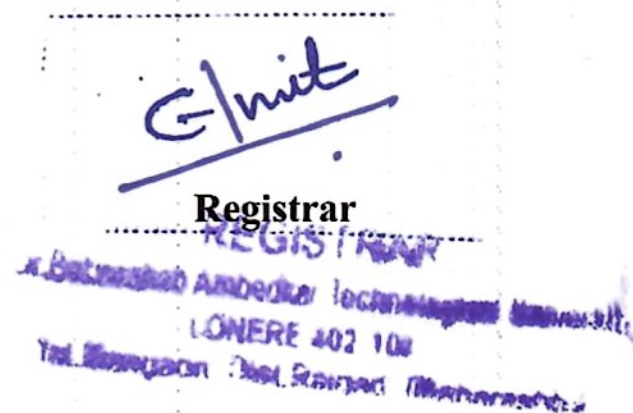
Following are the Observations of the Local Inspection Committee which must be compiled with.
